# A. **"23 Schoolhouse Road" Application for Special Exception Use** for construction of a 3,429.8 s.f. barn.

23 Schoolhouse Road, Map 27, Lot 26, Business B-4 District Applicant/Owner: Anthony Ruitto, 23 Schoolhouse Road, LLC Agent: Joe Wren, P.E. ACTION: Review and report to ZC for their 3/18/2024 public hearing

Joe Wren and owner Anthony Ruitto presented and answered questions. Mr. Wren explained that Mr. Ruitto acquired property from the Vietnamese restaurant and would like to put a barn there. Mr. Wren showed the site, building plans, and site plan, and discussed the roofing, façade, landscaping and lighting. Mr. Ruitto provided material samples.

E. Grochowski asked how high the lights will be and Mr. Wren stated that they will be just over the doors, about 7 feet high. On the garage bays, the doors are 14 feet high so the lights will be about 6 feet higher. A. Laferriere asked if there will be a dumpster and Mr. Ruitto stated that it is just a rollout. E. Grochowski asked about the garage doors and Mr. Ruitto explained that they will be regular house garage doors with a glass panel that he plans to be black; he also stated that he will not keep the lights on. E. Grochowski stated that solid doors would be fine and expressed a preference for black doors.
